IT'S ABOUT COMING TOGETHER FOR ONE ANOTHER

Alumni 6-10 years out of law school have told us they want to give back. Some have told us we need to make it much clearer how much any gift made, <u>any</u> gift at all, will be appreciated.

Gifts of any size make a very big difference.

The size of the gift does not matter.

The key is the total number of recent graduates making small gifts. If 75% of graduates in the Classes of 2003-2007 gave \$180/year (\$15/month), the Law School would be able to award over \$37,500 in new student support.
