
2L Samuel Taub creates eviction tracking tool that will benefit vulnerable New Mexicans

Samuel Taub used his unique skill set to create a powerful analytic tool designed to reveal the effects of eviction policies in New Mexico. Under the direction of Professor Elizabeth Elia, Taub and a team of research assistants collaborated with UNM SOL Clinic students to collect and aggregate eviction data—but the work was slow-going and tedious. UNM Law alumna Deb Haaland makes history, selected as interior secretary-designate

President Joe Biden selected New Mexico Congresswoman, and UNM alumna, Deb Haaland ('06) to serve as the interior secretary. If confirmed, she will become the first Native American to hold a cabinet position and will be the second-highest-ranking enrolled Native American ever to serve in the federal government. Haaland is no stranger to shattering glass ceilings. In 2019, she was one of the first two Native American women elected to the House of Representatives.



UNM Law Alumna Judge Julie Vargas Appointed to the New Mexico Supreme Court


New Mexico Court of Appeals Judge Julie Vargas ('93) was appointed by fellow UNM Law alumna Governor Michelle Lujan Grisham to the New Mexico Supreme Court. Judge Vargas was elected to the Court of Appeals in 2016 and has taught Appellate Decision-Making as an adjunct professor at the UNM School of Law. Vargas will take the seat left empty by fellow UNM Law alumna Justice Judith Nakamura ('89), who retired in December 2020.

\$17,000 Anonymous Gift to Marshall Brennan Constitutional Literacy Project

Directed by UNM Law alumna Lalita Moskowitz (2019) and supported by faculty advisor Professor Maryam Ahranjani, the UNM chapter of the Marshall-Brennan Constitutional Literacy Project received a generous donation from an anonymous donor who has contributed over \$40,000 to its work. Through UNM School of Law's Marshall-Brennan chapter, upper-level law students teach constitutional rights courses to high school students in culturally-diverse, high-poverty New Mexico public schools. The class culminates in a local moot court competition, and winners join high school students from chapters all over the country for a national competition in Washington, D.C.
