# OUR UNIQUE FIRST YEAR CURRICULUM

#### **The First Semester Doctrinal Courses**

The first semester doctrinal courses are Contracts, Criminal Law, and Torts.

#### Lab

Lab is a novel approach to teaching first-year students about the practice and substance of law through a hands-on introduction to legal skills. This course is unique to The University of New Mexico School of Law, which is a national leader in experiential learning.

#### Elements of Legal Argumentation (ELA) I

Elements of Legal Argumentation I is the foundational legal analysis and communication course. In the context of a problem-solving approach to legal writing, students learn how to do the information gathering, pre-thinking and argument development that are essential to good legal communication.

#### **The Second Semester Doctrinal Courses**

The second semester doctrinal courses are Civil Procedure I, Property I and Introduction to Constitutional Law.

#### Elements of Legal Argumentation (ELA) II

Elements of Legal Argumentation II continues the study and practice of legal reasoning and communication that began in ELA I. Students will have the opportunity to use their basic understanding of the core concepts and tools learned in ELA I as they complete a variety of both oral and written presentations.

#### **Introduction to Legal Research**

This one credit hour course builds on the legal research foundation acquired in ELA I.

#### **Elective**

First-year students also may take an optional elective during the spring semester, an option many law schools do not offer to 1L students.

# STUDY ABROAD

## MADRID SUMMER LAW INSTITUTE

The Madrid Summer Law Institute is a four-week, five-credit summer law program in Madrid, Spain. Classes meet only Mondays through Thursdays from 9:00 a.m. to 1:00 p.m., giving students ample opportunity to experience life in Europe.

The U.S. administration of the program takes place at the School of Law at The University of New Mexico, and all classes are offered at the Facultad de Ciencias Jurídicas y Sociales at the Universidad Rey Juan Carlos.

The Madrid Summer Law Institute offers classes on European Union law and international and comparative law. Courses are taught in English by faculty from both UNM School of Law and Universidad Rey Juan Carlos.

# WASHINGTON, D.C.

#### SEMESTER IN DC

In the UNM Law Semester in DC, students work 35 hours per week in an area government agency, non-profit or other approved organization under the supervision of a licensed attorney. There is a mandatory weekly 3 hour class component taught by a law school professor at a location to be determined each semester. In addition, students are paired with attorney mentors who meet with students, set up networking opportunities, social events, and provide invaluable guidance.

The Washington, D.C. Metro Area boasts the largest group of School of Law alumni outside the state of New Mexico. Our DC area alumni are very connected and engaged with the Law School despite the geographic distance. Our alumni have been instrumental in ensuring that students participating in the DC Program feel welcome, become easily acclimated to the city, and are well-supported. The law school has a significant presence in the Washington, D.C. metro area, and our mark on national policies and legal developments there will only increase as our program continues to grow and attract students eager to participate fully in all it has to offer.



With over 300 days of sunshine each year and a mild climate, Albuquerque is perfect for hiking in the Sandia Mountains, biking along the Rio Grande River, taking a ride on the tram, and strolling through the plazas.
